S.N.G.N. ROMGAZ S.A. has recently concluded three addenda with S.C. Electrocentrale Bucuresti S.A. (Add.no.18/2014, Add.no.19/ 2014 and Add.no. 20/2015) having as scope delivery of natural gas for the period January – September 2015.

Upon entering into force of Add.no.19/ 2014, Add.no.18/ 2014 shall become null and void.

Addendum no.20/2015 has been concluded pursuant to the implementation of the ANRE Order no.161/2014 on approving "The Methodology for allocating natural gas quantities resulted from the production activity, necessary to cover the household consumption and the consumption of thermal energy producers, exclusively for gas quantities used to generate thermal energy in cogeneration plants and in power plants, intended for household consumption". Implementation of the ANRE Order no. 161/2014 has resulted in the modification of the gas shares from current production and storage, as compared to the defined shares in Addendum No.19/ 2014.
