REPORT

on Public Supply and Works Procurement Contracts above EUR 500,000/procurement and Public Service Procurement Contracts above EUR 100,000/procurement concluded in the period between April 1, 2020 and June 30, 2020

Brief History

In accordance with the provisions of Article 22, item a) of the Board of Directors Resolution No. 22 /October 30, 2014 setting out that:

"By considering the decisions of the shareholders of S.N.G.N. ROMGAZ S.A. as set by the Resolution of the General Extraordinary Meeting of Shareholders No. 8/October 21, 2014, the Board of Directors decided the following: a) The quarterly information reports on procurement of goods and works above EUR 500,000/procurement and procurement of services above EUR 100,000/procurement shall be included in the Quarterly Report on the awarded pubic procurement contracts, prepared by the Contract Office within the Procurement Department, and after submitting it to the Board of Directors it will be published on the company's webpage. The report shall include information on the legal basis for conducting the procurement, the procurement procedure, object of procurement contract, value and duration of such."

The Procurement Department – The Procurement Reporting and Contract Monitoring Office shall prepare on a quarterly basis and submit to the Board of Directors the requested report.

Current Status

In accordance with the provisions of Article 22, item a) of the Board of Directors Resolution No. 22 /October 30, 2014, we hereby submit the *Report on public supply and works procurement contracts above EUR 500,000/procurement and public service procurement contracts above EUR 100,000/procurement* concluded by SNGN Romgaz SA in Q2 2020.

The sector-specific procurement activity was carried out in accordance with the provisions of Law no. 99/2016 on sector-specific procurement and Government Decision No. 394/2016 on approving the Enforcement Guidelines for awarding sector-specific contracts/framework agreement of Law No. 99/2016, as subsequently amended and supplemented.

Procurements of our company were financed from own financing sources.

The detailed situation of public supply and works contracts above EUR 500,000/ procurement and public service contracts above EUR 100,000/ procurement is shown below:

a. Public Supply Contracts above EUR 500,000/procurement

Contract no. 27425/May 7, 2020 concluded with S.C. Siemens Energy S.R.L. Bucuresti, for *Gas Compressor Spare Parts I: batch 1*, RON 6,229,954.5 over a period of 12 months (May 7, 2021). The procurement was carried out under the Open Tender procedure, with an estimated value of RON 6,574,616, sourced from production funds, 2020 Sector-Specific Procurement Plan–Section *Goods*, item P 932.1, the award of which was published under CAN 1033408/May 12, 2020. The procurement was carried out by the company's (headquarter) Procurement (Tender) Office.

b. Public Works Contracts above EUR 500,000/procurement

Contract no. 27382/April 29, 2020 concluded with S.C Dafora S.A., city of Mediaş, Sibiu County, for *Preliminary Preparatory Works, Drilling and Production Tests at 8 Fierbinti West Exploration Well*, amounting to RON 7,597,341.10 for a period of 171 days (October 17, 2020) from the notice to proceed. The procurement was made by in-house procurement procedure as it is an exception to Law 99/2016, Article 40.

The procurement has an estimated value of RON 8,362,088, sourced from investment funds, 2019 Sector-Specific Procurement Plan– Section *Works* – item 30.1, for which the Award Notice no. 14686/May 5, 2020 was published. The procurement was carried out by the company's (headquarter) Procurement (Tender) Office.

Contract No. 27619/June 3, 2020 concluded with S.C. Transgex S.A., city of Oradea, Bihor County, for *Preliminary Preparatory Works, Drilling and Production Tests at Glavanesti Exploration Well*, amounting to RON 4,260,023.78 for a period of 317 days (April 16,

2021). The procurement was carried out under the Open Tender procedure, with an estimated procurement value of RON 5,005,694, sourced from investments funds, 2019 Sector-Specific Procurement Plan, item L 30.4 –Section *Works*, for which the award notice CAN 1035173/09.06.2020 was published. The procurement was carried out by the company's (headquarter) Procurement (Tender) Office.

Romflex Sistem S.R.L., city of Râmnicu Vâlcea, Vâlcea County, for *Software Update License and Support Services for Oracle Software Licenses and Technology owned by S.N.G.N. Romgaz S.A.* amounting to RON 2,093,000.00, for a period of 273 days (March 3, 2021). Open tender procedure was applied, with an estimated value of RON 2,175,000, sourced from production funds, 2020 Sector-Specific Procurement Plan, Section *Services* item S 162.5, for which Award Notice CAN 1035099/June 10, 2020 was published. The procurement procedure was carried out by the Procurement (Tender) Office (at the company's headquarters).
- Contract no. 27718/ June 25, 2020 concluded with S.C. Autocomexim S.R.L., city of Braşov, County of Braşov for *Capitalizable Repairs of Intervention Rigs* amounting to RON 949,640 for a period of 365 days (June 25, 2021). The procurement was carried out under the Open Tender procedure, with an estimated value of RON 1,330,000, sourced from investment funds, Sector-Specific Procurement Plan Section Services item S 47.4, for which Award Notice CAN 1036306/June 25, 2020 was published. The procurement procedure was carried out by the Medias Branch of Well Workover, Recompletions and Special Well Operations.
