#### REPORT

# on Public Procurement Contracts for Goods and Works above EUR 500,000/procurement and Public Procurement Contracts for Services above EUR 100,000/procurement concluded during July 1, 2020-September 30, 2020

### **Brief History**

Considering Article 22, item a) of the Board of Directors Resolution No. 22 /October 30, 2014 providing that:

"By considering the decisions of S.N.G.N. ROMGAZ S.A. shareholders established in the General Extraordinary Meeting of Shareholders Resolution No. 8/October 21, 2014, the Board of Directors decided the following: a) Quarterly information reports on procurement of goods and works above EUR 500,000/procurement and procurement of services above EUR 100,000/procurement shall be included in the Quarterly Report on the awarded pubic procurement contracts, prepared by the Contract Office of the Procurement Department, and after submitting it to the Board of Directors it will be published on the company's webpage. The report shall include information on the legal basis for conducting the procurement, the procurement procedure, and object of procurement contract, value and duration of such."

The Procurement Department – The Procurement Reporting and Contract Monitoring Office shall prepare on a quarterly basis and submit to the Board of Directors the requested report.

#### **Current Status**

In accordance with the provisions of Article 22, item a) of the Board of Directors Resolution No. 22 /October 30, 2014, we hereby submit the *Report on public procurement contracts for goods and*

The sector-specific procurement activity was carried out in accordance with the provisions of Law no. 99/2016 on sector-specific procurement and Government Decision No. 394/2016 on approving the Enforcement Guidelines for awarding sector-specific contracts/framework agreement of Law No. 99/2016, as subsequently amended and supplemented.

Procurements were carried out in compliance with ROMGAZ Annual Program of Sector-Specific Procurements (procurements of goods, works and services), as approved by ROMGAZ Management. Our company finances procurements from own financing sources.

In Q3 2020, S.N.G.N. ROMGAZ S.A. awarded public goods and works contracts above EUR500,000/procurement and public services contracts above EUR 100,000/procurement, as summarized below:

Below is the detailed situation of public goods and works contracts above EUR 500,000/ procurement and public services contracts above EUR 100,000/ procurement:

### a. Public Goods Contracts above 500,000 Euro/Procurement

Contract no. 28718/September 24, 2020 concluded with încheiat cu S.C. Sutech S.R.L, located Mediaş, Sibiu county, for a *Coiled Tubing Unit 1 1/2 x 3,500 m* in amount of RON 13,599,000 over a period of 12 months. The procurement was carried out under the Open Tender procedure, with an estimated value of RON 13,700,000 sourced from investment funds, Annual Sector-Specific Procurement Plan 2020 –Section Goods – item P 642.3, the award of which was published under CAN 1041812/September 28, 2020. The procurement was carried out by the company's (headquarters) Procurement (Tender) Office.

## b. Public Works Contracts above EUR 500,000/procurement

Contract no. 28411/August 20, 2020 concluded with S.C Foraj Sonde S.A., city of Craiova, Dolj County, for *Preliminary Preparatory Works, Drilling and Production Tests at 8 Herepea West Exploration Well*, in amount of RON 3,826,206.72. Contract becomes effective on its execution date by both parties and ends on the expiration of the contract security (6 months from the works acceptance protocol). The procurement was made by inhouse procurement procedure as it is an exception to Law 99/2016, Article 40. The procurement has an estimated value of RON 5,314,176 sourced from investment funds, Annual Sector-Specific Procurement Plan 2020- Works Section – item L 34.7, for which the Award Notice no. 26558/August 24, 2020 was published. The procurement was carried out by the company's (headquarters) Procurement (Tender) Office

Contract no. 28463/August 24, 2020 concluded with S.C Foraj Sonde S.A., Craiova, Dolj County, for *Preliminary Preparatory Works, Drilling and Production Tests at 5 Greci Exploration Well*, amounting to RON 9,466,832.27, for a period of 359 days. The procurement was carried out through an in-house procurement procedure as it is an exception of Law 99/2016, art. 40, with and estimated value of RON 9,986.110, sourced from investment funds, 2019 Sector-Specific Procurement Plan – Section *Works* - item L 30.3, for which the Award Notice no. 26549/August 24, 2020 was published. The procurement was carried out by the company's (headquarters) Procurement (Tender) Office.

### c. Public Services Contracts above EUR 100,000/procurement

Contract no. 28471/August 25, 2020 concluded with S.C. Rompetrol Well Services S.A., Ploiești, for *Cementing Services for Natural Gas Wells, Including Supply of Cement Slurry*, amounting to RON 39,996,498.12, for a period of 730 days. The procurement was carried out under the Open Tender procedure, with an estimated value of RON 40,000.000, sourced from investment funds, 2020 Sector-Specific Procurement Plan – Section *Services* - item S 168'.1, for which the Award Notice no. CAN 104036/September 09, 2020 was published. The procurement was carried out by the company's (headquarters) Procurement (Tender) Office.

- Subsequent Contract no. 28585/ September 03, 2020 year II, to the Framework Agreement no, 24149/June 13, 2019 concluded with Anvergo S.R.L., Târgu Mureş, Mureş, County, for *Preparation, Usage and Disposal Services for Productive Layer Fluids, Viscous Packs, Surfactant Packs for Chemical Wash, Packer Fluids*, in amount of RON 845,898.55, for a period of 12 months.

Attached to this Report is the Q3 2020 Statement on Public Supply and Works Contracts above EUR 500,000 and Public Service Contracts above EUR 100,000–Annex 1, drafted in accordance with Government Decision 583/August 10, 2016 on approving the 2016-2020 National Anticorruption Strategy, performance indicator sets, risks associated with the objectives and measures of the strategy and verification sources, the inventory of institutional transparency and corruption prevention measures, assessment indicators, and publishing standards of public information.
