REQUEST

to retify the Natural Gas Sale Contract No. VG2/2023 concluded with S Electrocentrale Bucureşti SA

Whereas:

- S Electrocentrale Bucureşti SA (ELCEN), through letter no.1376/January 12, 2023, registered with Romgaz under no. 1581/January 13, 2023, requested us to analyze the possibility to deliver the quantity of 690,000 MWh natural gas, during January 20, 2023 – February 10, 2023, *"in order to ensure continuous delivery of heat during winter for the next period*";
- Following the analysis of ELCEN request, pursuant to Resolution no. 1/2023 of January 13, 2023 meeting, Romgaz Board of Directors "agrees to send ELCEN an offer and, if applicable, to conclude a contract, under the following conditions:
 - Delivery period: January 20 February 10, 2023;
 - Contracted natural gas quantity: 690,000 MWh;
 - Payment of the equivalent value of natural gas delivered shall be made in advance, prior to delivery";
- In January 13, 2023, through letter no. 1782, Romgaz sent a natural gas sale offer to ELCEN under the following conditions:
 - o Delivery period: January 20, 2023, at 7:00 February 11, 2023, at 7:00;
 - Contracted quantity: 690,000 MWh;
 - Delivery point: in VTP of the NTS;
 - Natural gas sale price is in accordance with Romgaz Natural Gas Sales Policy and the invoice price in accordance with the provisions of GEO No. 27/2022¹, as subsequently amended and supplemented;
 - Advance payment, in (3) installments, for the natural gas quantity related to a 7 days delivery period;

¹ GEO No. 27 of March 18, 2022 on measures applicable to final costumers in the electricity and natural gas market during April 1, 2022 – March 31, 2023 as well as on amending and supplementing certain legislative acts in the field of energy, as subsequently amended and supplemented.
