Protocol to establish the non-observance of conditions required for the performance of S.N.G.N. "Romgaz" S.A. OGMS convened for 25.09.2019

Concluded today, 25.09.2019, at the headquarters of S.N.G.N. "ROMGAZ" – S.A. in Mediaș, C.I. Motaș Square, no. 4, Sibiu County, according to S.N.G.N. "ROMGAZ" – S.A. Articles of Incorporation Article 14, par. 6.

Hereby, the following is established in connection with the OGMS meeting convened for 25.09.2019:

- Mr. Parpală Caius-Mihai, director of S.N.G.N. ROMGAZ S.A., was authorized to chair the OGMS on 25.09.2019, according to the mandate conveyed by Mrs. Stan-Olteanu Manuela-Petronela, Chairman of the BoD; mandate registered at S.N.G.N. ROMGAZ S.A. under No. 32058/24.09.2019.
- Mrs. Anca Antal, legal counselor, was appointed Technical Secretary of OGMS on 25.09.2019
- OGMS Convening Notice was published in the Official Journal of Romania –Part IV No. 3445 of 20.08.2019, in "Bursa" daily newspaper No. 150 on 20.08.2019 and on the company's website (<u>www.romgaz.ro</u>) as of 20.08.2019, as such, the formalities for convening the OGMS on 25.09.2019 were fulfilled.
- According to S.N.G.N. "Romgaz" S.A. Articles of Incorporation, Article 15, par. 12: "The presence of shareholders holding at least half of the total voting rights, and the decision-making by a majority of validly expressed votes are conditions required for the validity of ordinary general meeting deliberations upon its first convening"
- The total number of votes which can be casted during OGMS on 25.09.2019, is: 385.422.400.
- For the OGMS on 25.09.2019, no shareholder was present.
