In compliance with **Article 234 paragraph 1, item i)** of the **F.S.A. Regulation No. 5/2018** on Issuers of Financial Instruments and Market Operations, S.N.G.N. Romgaz S.A reports the conclusion with **Exim Banca Românească S.A.**, on March 31, 2025, of a term deposit without auto-renewal option, with the interest rate negotiated, in amount of **RON 250,000,000.00**, due on **July 14, 2025**.

The interest rate applied to the above mentioned deposit is **5.88%** per year.

We mention that, S.N.G.N Romgaz S.A has had deposits at Exim Banca Romaneasca S.A. with a cumulative value over 12 months exceeding the materiality threshold of 10% of the net turnover related to 2023 financial year. Some of these deposits matured before March 31, 2025.
