In accordance with the provisions of Article 22, letter a) of Board Resolution No. 22/October 30, 2014, we hereby provide the Report on contracts related to sector procurement of goods and works of a value higher than EUR 500,000/procurement and services higher than EUR 100,000/procurement, respectively, concluded by S.N.G.N. Romgaz S.A. in Q2 2024.

The sector procurement activity was carried out in accordance with the provisions of Law No. 99/2016 on sector procurement and of Government Decision No. 394/2016 approving the Enforcement Guidelines for awarding sector contract/framework agreement of Law No. 99/2016, as subsequently amended and supplemented.

The acquisitions were made in compliance with S.N.G.N. ROMGAZ S.A. 2023 - 2024 Sector Procurement Annual Program (goods, works and services procurement), approved by S.N.G.N. Romgaz S.A. Management. The acquisitions made by our company were made through own source financing.
